How much energy storage does the UK have?

The UK has 2.4GW/2.6GWh of operational energy storage across 161 sites, with 20.2GW additional approved in planning. The UK is deploying increasing amounts of new utility energy storage capacity each year. The total pipeline for UK energy storage is now at 61.5GW across 1,319 sites.

How many GW of battery storage are there in Great Britain?

A total of 4.3GW is under construction, with another 30.4GW consented, and a further 26GW submitted for planning permission. Meanwhile, an additional 30.4GW is in the early stages of development. But which suppliers are driving Great Britain's battery storage revolution?

How much money does the UK energy sector invest in 2022?

In 2022 the UK energy industry supported over 734,000 jobs and the entire energy sector supply chain contributed \$190bn to the UK economy. The energy sector invested \$17bn in the UK in 2022, which represented 7% of total investment. There is over \$125bn in planned investment in new energy sources over the next decade.

Are GB battery manufacturers making inroads?

Success has so far been limited – as the chart below shows, as of April 2024, not a single GB battery manufacturer or containerised battery system supplier has played a role in delivering battery energy storage projects of 50MWh or greater. Yet, there are a number of GB battery manufacturers that are seeking to make inroads into the market.




