How are energy storage systems incentivized?

Energy storage systems are incentivized based on the watt-hour AC (Wh-AC) of the system. Within General Market budgets, the Large-Scale Storage budget provides incentives for installing all nonresidential qualifying energy storage technologies and residential systems with sizes greater than 10 kW.

Who is eligible for energy storage incentives?

You may be eligible if you are in a High Fire-Threat District (HFTD) or have been affected by two or more Public Safety Power Shutoff (PSPS) or wildfire events. Energy storage incentives are reduced as the duration of energy storage (Wh) increases.

Do I NEED Solar to qualify for energy storage?

No, you do not need to have solar to qualify for this program. Energy storage allows for self-supply during outages for added resiliency. If your main electrical panel is configured to only have critical load (e.g., a few lights, refrigerator, A/C) on, your energy storage system will last longer.

How do I claim a residential energy credit?

File Form 5695, Residential Energy Credits with your tax return to claim the credit. You must claim the credit for the tax year when the property is installed, not merely purchased. For additional instructions on how to claim the credit for residential clean energy follow our step-by-step guide.

How do I claim a battery storage credit?

Battery storage technology must have a capacity of at least 3 kilowatt hours. File Form 5695, Residential Energy Credits with your tax return to claim the credit. You must claim the credit for the tax year when the property is installed, not merely purchased.

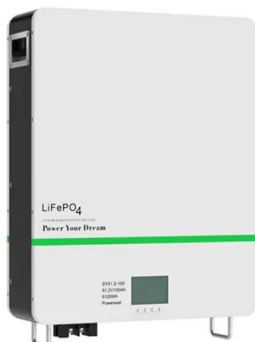
